**ALL entries must be received by no later than 7 days prior to show date.**  
**Late entries will carry a fee of \$10 per class, and are only available if scheduling allows.**

- Ribbons will be awarded to places 1-6 in each class. Ties will be broken using collective marks.
- Meadowlark School Horses are available to students on a first-come-first-served basis and students may be required to share a school horse with others.
- Riders should list a division, and classes will be split by division if numbers allow. Riders may sign up for multiple different Tests of Choice within same class, and if enough riders sign up for same test, a separate class will be formed. Horses listed as Green should have limited experience under-saddle and be in their first season of showing.
- Current negative coggins is required for all horses hauling in. SEI approved helmets must be worn by **all** riders, when mounted, and safe footgear is required for all classes. Formal attire is suggested, but definitely not required.
- Overnight stalls are very limited, and are \$50. Please contact us prior to signing up to inquire after availability. As we are a boarding facility, horses hauling in may arrive no earlier than 5:30PM the night before and must haul out within 2 hours after the show. Day stalls are \$25 for the day.
- Overnight and Day stalls must be cleaned out prior to departure of show grounds, and area must be tidy.
- For ride times, please text Emily no earlier than 48 hours prior to show start at (734) 776-8103.
- All Intro tests will be ridden in the small arena. Training level tests will be the small or large arena (at management's discretion), and First/Second level tests will be ridden in the large arena.
